We also perform work on wider assurance engagements and have a large and growing internal audit base.

Graduates joining the Audit Programme will also have the chance to work in a specific business area whilst studying towards a valuable professional qualification. Additionally, all of our employees have access to an extensive programme of internal training geared towards your career and personal development, meaning progression can be rapid. From the start you'll be an integral part of a team, and throughout your training you will be coached and supported to manage and develop your wider team, together with nurturing relationships and delivering quality audit work.

In depth

At KPMG the fundamental role of an auditor is defined as reporting on whether the annual accounts show 'a true and fair view' of the company's financial activity and position to its shareholders.

What to expect

Training and development

The training, development and regulation of our Audit professionals is critical to the future success of our business, which is why our people are trained to become experts in their field and supported to study for a professional qualification. We currently offer either the ACA or CA depending on office location. For Scottish offices we offer the ICAS route (CA). For all other offices we offer two ACA routes that you will be able to select upon applying. These are the ACA Intensive Programme or our ACA Empowered Programme.

Intensive Programme

The Intensive Programme is KPMG's front-loaded, classroom-based ACA product which focuses on upskilling trainees more quickly. This means that for the first circa 10 months of your training contract you will solely focus on passing 14 out of 15 ACA exams, and come into the business on two work experience placements. One is a structured, work experience placement in the busy season of your programme, and the second comes after you have completed your 14 exams.

The entire programme is supported by a wide range of mechanisms that will be applied by your tuition provider or KPMG when you require them, but due to the varied pace of the programme you will need to be really dedicated in your approach to learning.

This product allows you to focus purely on your professional qualification in your first year. In the remaining two years of your training contract you can concentrate on

building up a fantastic range of work experience (with only one exam left to complete) and will have the technical knowledge to apply within the workplace.

The three main training hubs for the Intensive Programme are London, Birmingham and Manchester. Regardless of the selected home office, you will be expected to re-locate to one area in order to dedicate the time to attend the programme for the first circa 10 months.

Empowered Programme

The Empowered Programme is KPMG's blended ACA product. Where the onus is on you to take ownership of your studies and help shape your learning.

The programme uses innovative technology and is delivered via a blend of Online Classroom Live and recorded courses plus in-centre classroom courses. It also has wrap-around support which consists of dedicated professional coaches, online portal content and live and recorded additional study sessions, which means there is a form of support for your every need.

This blended approach enables you to study and learn the content at a pace suited to your learning style, but ensures all are at the right technical level prior to stepping into revision elements so you can focus on your exam technique before the exam.

The structure of the programme spreads the ACA examinations over the lifetime of the three year training contract so that you are able to build up your technical knowledge, and can gradually apply what you are learning in training to your workplace experience.

ICAS Programme

The ICAS Programme is KPMG's CA product offered to all Scottish offices. The programme consists of classroom-based tuition and revision, with wrap-around online and self-study learning. The training is block release which means you are out of the business for four to eight week periods at a time enabling you to focus solely on your professional qualification and then go back into the business once complete. The structure of the programme requires you to take ownership of your studies but also provides a good balance, allowing you to shape your own learning and seek support as and when you need it.

ICAS is both the tuition provider and the professional body which means they both create and teach the material you require to gain the relevant knowledge expected for their syllabus.

The structure of the programme spreads the CA examinations over the lifetime of the three year training contract, so that you are able to build up your technical knowledge, and can gradually apply what you are learning in training to your workplace experience.

KPMG is extremely confident and proud of both their ACA and CA products as they support all learning styles and ensure a supportive and inclusive learning environment. Therefore, regardless of route, you will be supported by KPMG's dedicated Professional Qualification Training and Accreditation team whose focus is to ensure that each KPMG trainee fulfils their potential.

All programmes take three years to complete. They just offer different routes to achieving success. You should not underestimate how much of your first three years will be spent studying and therefore it is imperative you really think about your learning style, and be sure that you are

The recruitment process

I was impressed with how quick the whole process was! Between sending my application and finding out the final decision, it must have only been about 3 weeks. I loved how efficient and succinct the hiring process was. It was great also having a constant point of contact, so there was an ongoing relationship with the firm, before you've even started working there.

Qualifications and support

I'm currently on the Empowered programme, studying the ACA. The support has been really good from the get go. The mobile learning aspect took me a while to get used to, but there are so many forms of support that you never feel alone.

Day-to-day

My day to day tends to be off-site at the companies I am auditing. I'm very rarely at the office. I tend to go to the office of the company we are auditing, where a KPMG team is usually already on site. After researching the company previously, I am usually given an area (for example revenue, debtors, creditors) to commence testing. I am in regular contact with contacts at the company being audited, which is one of the best bits of the job. I love building a rapport with them and actually making a difference to the business. This job is definitely hands on, with lots of contact with varying seniority levels. My smallest team has been a two person team, and my largest has been 15, so really, no two days are the same!

My advice

Really do your research on the firm and the changing regulatory environment. We are in such an exciting and changing time for professional services, so it's really impressive when candidates can show that they really have their finger on the pulse!

Social life

There are a number of opportunities for you to get together with your colleagues on a less formal basis throughout the year, such as the Christmas Party, quarterly drinks as well as a range of clubs and societies to match your interests. At the beginning of the year you may also be invited to contribute to the department's social fund which allows the social committee to organise more events in the year.

Further career opportunities at KPMG

Opportunities that I know of include the opportunity to have a secondment abroad, at KPMG firms in other countries. Because the work is so varied, there is also the chance to travel with work. For example, within my department we work in New York, Jakarta, Panama and Atlanta. Of course, there's also the opportunity to work in another department within KPMG, for example Advisory or Tax.

FAQs

What will my career in audit be like?

As you progress through your Graduate Programme, you'll gradually take on more responsibility either for leading teams and audit areas requiring technical expertise or subject to judgement. Within audit, you'll have the support and scope to develop specific industry skills, or you may even choose to work at a more senior level on projects within different parts of audit.

Then, once you've passed your professional chartered exams, you'll find a vast range of opportunities open to you as KPMG has already invested in numerous learning programmes for qualified individuals.

Isn't Audit just ticking invoices?

What's the difference between audit in the public and private sectors?

In the public sector, we're appointed as external auditors to many health and local government bodies as well as universities and housing associations. For these bodies, the audit regime goes beyond the focus on auditing annual accounts to a broader assessment of value for money. We also have a significant internal audit and wider assurance base, so we spend time helping improve wide ranging aspects of their organisations, not just their finance function.

Is there much travel involved in the role?

Our work takes us to where our audit engagements are, so we spend a lot of time working at their offices. The audit work is both UK and overseas, so this means there will be travel involved – it's unlikely that you'll be going to the same office every day of the year, so be prepared to frequently change your routine.

For the Intensive Programme, you will be expected to reside in the training location of the programme you have joined for the first circa 10 months, regardless of your home office location.

For Empowered, you will be allocated a training centre near your home office which you will be expected to travel to. However, a lot of the programme will be completed via Online Classroom Live.

For the ICAS programme, you will be asked on occasion to travel for your classroom based tuition and/or revision to other areas within the UK.

How important are my skills in technology- based systems like Excel?

In this evolving environment, the use of technology and 'big data' is ever more present. It is not a thing of the future but audit of today. While KPMG does not expect all of its graduates to be experts in technology, a working knowledge of systems like Excel is useful, as you will be using these on a daily basis.
